





Henry M. Bates Dean of University of Michigan Law School, 1910-1939

Award Data

- \$125,000 to give
- 10-20 applications approved each year
- 70-75% of applicants are successful
- Lengths vary from 2 weeks to 12 months
- Awards vary from \$2,000 to \$14,000
- \$5,000 \$7,500 average award
- 3 months average length
