WHILE AT FLORIDA, I WAS SCHTCALE

PAPULATION. BEFORE BEENING RELEASE ONE MUST GO UP ON A
CAPTAIN REVEIN, WHICH CONSIST OF THE CAPTAIN AND WARDEN
APPROVAL I WAS RELEASE ON THEIR APPROVAL ON THE 10<sup>TH</sup> OF JANUARY.
FOUR DAYS LATER, I WAS TRANSFER HERE (D.C.I.) WHERE I WAS
PLACE BACK IN DISCIPLINARY SEGREGATION WITHOUT A
DISCIPLINARY WRITE UP OR ANY COURT APPEARANCE. I TALK TO
SERGEANT, LIEUTENANT, CAPTAIN, AND MAJOR REGARDING MY SITUATION.
THEY ALL QUOTE, WE DON'T KNOW WHAT TO TELL YOU. MENTAL
HEALTH CAME TO SEENABOUT PERSONAL INFORMATION. I
INTRODUCE HIM TO MY SITUATION, AND HE ASK, WHAT ARE
YOU INCARCERATE FOR?" I STATED MY CHARGE WHICH IS
ARM ROBBERY. HE STATED MY CHARGE YOULDN'T HAD ME IN
DISCIPLINARY SEGREGATION. AFTER THAT HE QUOTED, I
DON'T KNOW WHAT TO TELL YOU."

T'VE RECEIVE A NOTE FROM HIS SECRETARY, MS.

STATING MY ARR HAVE BEEN REJECTED "DUE TO TRANSFER". I DIDN'T
UNDERSTAND THE RESPOND GIVEN; THEREFORE, I FILL OUT AN
CORRESPONDENCE FORM TO WARDEN

I'VE RECEIVE A RESPOND FOR HIM A COUPLE OF DAYS LATER HE
INFORM ME THAT I WAS PLACE IN MAXIMUM SECURITY AT
FLORIDA DUE TO MY WRITE-UPS. MY ARGUMENT WAS THAT FLORIDA
WHOLE" INSTITUTION WAS A MAXIMUM INSTITUTION. SO NOW
ADMINISTRATIVE SEGREGATION THERE BECOME SUPER MAXIMUM
SECURITY.

I FELT LIKE I WAS GETTING NOWHERE WITH THE ARP SYSTEM UNTIL, ABOUT (2) TWO WEEKS LATER I RELEIVE A RESPOND FROM THE ARP WHICH WAS DENZED. I FORWARD THE PAPERNORK BACK TO START STEP 2. AFTERWARD, I WAS SENT TO THE WORKING CELL BLOCK (W.C.B.) WHICH CONSIST OF GOING INTO THE FIELD WORKING; CUTTING GRASS WITH A HOE; PLANTING VEGETABLE; UR JUST SHOYELING DIRT AROUND. WORK HOURS: MON. - THURS. 8 AM - 10 45 AM; COME IN TO A FULL STRIP SHARCH; LUNCH 12 NOON - IPM; WORK HOURS: 1 pm - 3:30, COME BACK IN TO A FULL STRIP SCARCH; FINALLY, DINNER. DN FRIDAY INMATE WORK HALF-A. DAYS UNSAMITARY PRACTICE: AFTER CONTING OUT THE FIELD FOR CHOW TIME INMATE ARE ASSIGN TO PASS OUT THE TRAYS WHICH COME FROM A BLOCK OR (2) AWAY ON A CART WITHOUT COVERING. WHILE 100 OR SO INMATE BEENING SEARCH, THE FOOD CART SIT OUTSIDE UNATTENDED. STILL THE CORRECTIONAL DEFICER HAVE TO SCARCH UNDER EVERY TRAYS FOR CONTRABAND. BY THE TIME WE RECEIVE THE SMALL PUTION OF FOOD, IT BE COLD. I WROTE AN ARP ON BUT YET TO GET A RESPOND BACK FORM STEP 2.
