The Department of Corrections has received your Government Records Request Your request has been assigned Request ID No 9970 for tracking purposes You submitted a request for copies of the following records

- 1 Any current prisoner handbook or manual (including any inmate orientation handbook or manual), system-wide or institution specific
- All current prisoner grievance regulations, policies, guidelines, manuals, directives, rules, etc, including general grievance policies/guidelines/etc and specific grievance policies/guidelines/etc, relating to, for example, health care or sexual assault
  - By "grievance" we mean any grievance or complaint, whether formal or informal, whatever the subject matter
- 3 Any records, created or updated from 2003 to the present, tallying or reporting
  - The number of grievances filed and resolved each year,
  - The categories or subject matter of grievances filed and resolved, and number of grievances in each subject matter category used (for instance, grievances related to food, health care, use of force, etc., and including both ordinary and "sensitive" complaints such as those involving allegations of staff misconduct)
  - Grievance outcomes or resolutions each year, by subject matter category and year
  - Statistics or data on length of time to resolve grievances, by subject matter category and year
    - We are not requesting individual grievance records. We are only requesting records that summarize, aggregate, or compile grievance data

In response to item #3 of your request, please be advised that the only documents available that are partially responsive to your request exist for the years of 2005 - 2012 The 2013 statistics have yet to be compiled. In addition, the documents do not contain all the information you have requested as the remedies are not tracked in such a manner. The statistics available provide the number of remedy forms submitted per month, per institution, per year as well as the number of remedies that were not answered. These documents are 8 pages in length

In response to item #4 of your request, this office can provide you with the following

N J A C 10A 18 "Mail, Visits and Telephone" – 33 pages

In accordance with N J S A  $\,47\,$  1A-1 et seq , the above noted documents are being e-mailed as attachments to this correspondence free of charge

## **Denial of Access Appeal Info**

The New Jersey Open Public Records Act (N J S.A 47·1A-1 et seq ) permits a person who believes he or she has been illegally denied access to a public record to file a complaint with the Government Records Council (GRC), or file suit in Superior Court to challenge the decision and compel disclosure. This poster describes the procedures for taking these actions

## To file a complaint with the Government Records Council.

Contact the GRC by phone at 1-866-850-0511, by e-mail at gro@dca state nj us, or review the GRC web site at www nj gov/grc for information and to register your complaint

The GRC staff may be able to help resolve the problem over the phone. If not, you can receive a complaint form through the mail or from the web site.

When you file the written complaint, the GRC will offer you and the public agency non-adversarial, impartial mediation

If mediation is not agreed to or fails, the GRC will investigate the complaint

The investigation may result in findings or a formal decision by the GRC, which may include a hearing by the Council

In some cases, the Council can award attorneys fees or fine a records custodian for failing to provide records

Details of this process are available from the GRC

There is no fee to file a complaint with the GRC

## To file a complaint in Superior Court:

A requester may start a summary (expedited) lawsuit in the Superior Court A written complaint and order to show cause must be filed with the court

The court requires a \$200 filing fee, and you must serve the lawsuit papers on the appropriate public officials

The court will schedule a hearing and resolve the dispute

If you disagree with the court's decision, you may appeal the decision to the Appellate Division of Superior Court

If you are successful, you may be entitled to reasonable attorney fees

You may wish to consult with an attorney to learn about initiating and pursuing a summary lawsuit in the Superior Court
