UPON ARRIVAL AT DIXON  
CORRECTIONAL INSTITUTION ON JANUARY 14, 2006 FROM COLEMAN, FLORIDA.  
WHILE AT FLORIDA DUE TO AN EMERGENCY SITUATION I'VE RECEIVED A  
FEW WRITE-UPS, ITS ENCLOSE IN THE ENVELOPE ALONG WITH DOCUMENT  
REGARDING THIS LETTER. I HOPE THAT THIS LETTER TOUCHES YOU  
IN THE BEST SPIRIT, HEALTH, AND CONCERN.

WHILE AT FLORIDA, I WAS SENTENCE  
FOR THOSE CHARGES AND PROVE MYSELF WORTHY OF RETURNING TO  
POPULATION. BEFORE BEING RELEASE ONE MUST GO UP ON A  
CAPTAIN REVIEW, WHICH CONSIST OF THE CAPTAIN AND WARDEN  
APPROVAL. I WAS RELEASE ON THEIR APPROVAL ON THE 10<sup>TH</sup> OF JANUARY.  
FOUR DAYS LATER, I WAS TRANSFER HERE (D.C.I.) WHERE I WAS  
PLACE BACK IN DISCIPLINARY SEGREGATION WITHOUT A  
DISCIPLINARY WRITE-UP OR ANY COURT APPEARANCE. I TALK TO  
SERGEANT, LIEUTENANT, CAPTAIN, AND MAJOR REGARDING MY SITUATION.  
THEY ALL QUOTE, "WE DON'T KNOW WHAT TO TELL YOU." MENTAL  
HEALTH CAME TO SEE <sup>ME</sup> ABOUT PERSONAL INFORMATION. I  
INTRODUCE HIM TO MY SITUATION, AND HE ASK, "WHAT ARE  
YOU INCARCERATE FOR?" I STATED MY CHARGE WHICH IS  
ARM ROBBERY. HE STATED MY CHARGE WOULDN'T HAD ME IN  
DISCIPLINARY SEGREGATION. AFTER THAT HE QUOTED, "I  
DON'T KNOW WHAT TO TELL YOU."

SOME INMATE REFER ME TO ADMINISTRATIVE REMEDY PROCEDURE ARP TO GET SOME RESULT. ON THE 14<sup>TH</sup> OF JANUARY, I FILL OUT AN ARP ABOUT MY SITUATION AND FORWARD IT TO WARDEN [REDACTED]. ABOUT A MONTH LATER, I'VE RECEIVE A NOTE FROM HIS SECRETARY, MS. [REDACTED] STATING MY ARP HAVE BEEN REJECTED "DUE TO TRANSFER". I DIDN'T UNDERSTAND THE RESPOND GIVEN; THEREFORE, I FILL OUT AN CORRESPONDENCE FORM TO WARDEN [REDACTED]. THIS TIME I'VE RECEIVE A RESPOND FOR HIM A COUPLE OF DAYS LATER. HE INFORM ME THAT I WAS PLACE IN MAXIMUM SECURITY AT FLORIDA DUE TO MY WRITE-UPS. MY ARGUMENT WAS THAT FLORIDA "WHOLE" INSTITUTION WAS A MAXIMUM INSTITUTION. SO NOW ADMINISTRATIVE SEGREGATION THERE BECOME SUPER MAXIMUM SECURITY.

I FELT LIKE I WAS GETTING NOWHERE WITH THE ARP SYSTEM UNTIL, ABOUT (2) TWO WEEKS LATER I RECEIVE A RESPOND FROM THE ARP WHICH WAS DENIED. I FORWARD THE PAPERWORK BACK TO START STEP 2. AFTERNARD, I WAS SENT TO THE WORKING CELL BLOCK (W.C.B.) WHICH CONSIST OF GOING INTO THE FIELD WORKING; CUTTING GRASS WITH A HOE; PLANTING VEGETABLE; OR JUST SHOVELING DIRT AROUND. WORK HOURS: MON. - THURS. 8 AM - 10:45 AM; COME IN TO A FULL STRIP SEARCH; LUNCH 12 NOON - 1 PM; WORK HOURS: 1 PM - 3:30 PM; COME BACK IN TO A FULL STRIP SEARCH; FINALLY, DINNER. ON FRIDAY INMATE WORK HALF-A-DAYS. UNSANITARY PRACTICE: AFTER COMING OUT THE FIELD FOR CHOW TIME INMATE ARE ASSIGN TO PASS OUT THE TRAYS WHICH COME FROM A BLOCK OR (2) AWAY ON A CART WITHOUT COVERING. WHILE 100 OR 50 INMATE BEENTING SEARCH, THE FOOD CART SET OUTSIDE UNATTENDED. STILL THE CORRECTIONAL OFFICER HAVE TO SEARCH UNDER EVERY TRAYS FOR CONTRABAND. BY THE TIME WE RECEIVE THE SMALL PORTION OF FOOD, IT BE COLD. I WROTE AN ARP ON<sup>IT</sup> BUT YET TO GET A RESPOND BACK FORM STEP 2.

OFFICER: PAST OUT MEDICATION RIGHT AFTER L.H.W.

AT 5:00PM, THE T.V.'S  
COME ON; WHICH ARE FOR THE NEWS PURPOSE. I NEVER  
GOT THE CHANCE TO READ THE POST POLICY REGARDING THE  
RULE AND REGULATION BUT DO UNDERSTAND RIGHT FROM WRONG.  
NEWS COME ON AT 5:00AM; 5:00PM; AND 10:00PM. THEREFORE,  
THE T.V. SHOULD CONSIST OF THEM THREE HOURS, BUT  
T.V. HOURS: LEVEL 1 5:00PM - 7PM; LEVEL 2 5:00PM - 9PM  
EVERYONE GET EXTRA (1) HOUR ON WEEKENDS

SHIFT CHANGE AT 6:00PM  
THAT WHEN SHOWER START, 10 MIN. TOP IN SHOWER. FROM  
SHAVING TO CLEANING SOMETIME THE WATER BE RUNNING  
COLD ALONG WITH THE FAN BLOWING COLD AIR. THE  
LAST PERSON (INMATE) MAY SHOWER AT 10:00 PM OR LATER.  
LIGHTS GOES OUT AT 10PM. WE ALL RECEIVE (1) SET  
OF COLTHING EVERY MORNING.

I'VE NOT REPORT THIS  
MATTER DUE TO THE SYSTEM, PUTS A.R.P.'S ON BACKLOG.  
I WAS WAITING ON A RESPOND FROM MY FIRST A.R.P.  
FROM THE STEP 2, WHEN I RECEIVE A RESPOND FROM  
THE A.R.P. ABOUT THE FOOD. I FORWARD IT BACK THE  
NEXT DAY. FOR SOME ODD REASON, THE LIEUTENANT [REDACTED]  
ME ABOUT IT. ASKING, "WHERE WAS IT" I QUOTED I  
HAVE FORWARD IT TO BEGIN STEP 2. FROM CELL BLOCK  
B TO WORKING CELL BLOCK, I WAS ASK AND WAS  
SECRETLY SEARCH ABOUT THE WHEREABOUT OF THE A.R.P.  
I'M CONCISE THAT THEY ALL THOUGHT I WAS LYING.

Upon being received at Dixon Correctional Institute, you were placed in Administrative Segregation/Hold Working Cellblock by Dixon Correctional Institute's Initial Intake Board. This board has the authority to assign inmates to any housing and custody status as they deem appropriate. Since you received disciplinary reports while in Florida for Engaging or Encouraging a Group Demonstration (Rule #212), Engaging in Sexual Acts (Rule #205), and Refusing to Obey an Order by a Staff Member (Rule #307), it was determined by the Intake Board that you be assigned to Maximum Custody, Hold Working Cellblock. When you have been properly staffed by Mental Health/Medical, you will be reviewed by the Cellblock Review Board within 90 days from the date of your arrival at Dixon Correctional Institute, in order to determine whether or not you can be downgraded to Medium Custody. Your conduct record while at Dixon will be considered to make this determination. Request for Administrative Remedy is denied.
